Dr. Al Houqani is an Associate Professor at United Arab Emirates University, Consultant of Internal Medicine, Respiriology and Sleep Medicine. He served as the Assistant Dean for Medical Education for 5 years. Dr. Al Houqani is a Fellow of Royal College of Physicians and Surgeons of Canada, Internal Medicine & Respiriology. He published 26 papers on tobacco and sleep disorders, and he was a keynote speaker in various international and regional conferences, workshops, and webinars.

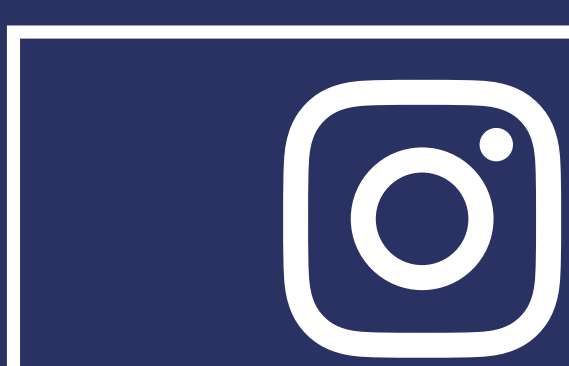
Dr Badr research work and interests include health systems strengthening, health workforce policy, migration, health professions education, and health workforce regulation.
